Pursuant to Article 33 paragraph 7 of the Law on Lobbying (“Official Gazette of the Republic of North Macedonia “No.122/2021), the State Commission for Prevention of Corruption, on the 56th Session held on December 10, 2021 adopted the following

RULEBOOK ON THE FORM AND CONTENT OF THE MISDEMEANOR PAYMENT ORDER

Article 1

This Rulebook regulates the form and content of the misdemeanor payment order referred to in Article 33 paragraph 3 of the Law on Lobbying.

Article 2

The misdemeanor payment order for a natural person is printed on white paper in A4 format.

The form and content of the misdemeanor payment order referred to in paragraph 1 of this Article are given in Annex 1 which is an integral part of this Rulebook.

Article 3

The misdemeanor payment order for a legal entity is printed on white paper in A4 format.

The form and content of the misdemeanor payment order referred to in paragraph 1 of this Article are given in Annex 2 which is an integral part of this Rulebook.

Article 4

This Rulebook shall enter into force on the eighth day of its publication in the “Official Gazette of the Republic of North Macedonia”, and it shall be implemented from the day of the implementation of the Law on Lobbying (“Official Gazette of the Republic of North Macedonia “No. 122/2021).
