Activity 2. Support to the implementation of the elements of the integrity system in the local self-government units					
The Mission and the SCPC will further support local administrations to strengthen the integrity system. Technical experts will be engaged and four two-day training sessions will be organized for integrity officers, covering all elements of the integrity policy and helping to overcome implementation challenges. In addition, a Handbook on Preventing Conflicts of Interest in the local selfgovernment units will be developed, in which most frequent cases with questions and answers processed in the SCPC will be presented for local officials seeking clarification on real, potential or apparent conflicts of interest in various areas. The publication will be prepared in three languages and posted on the OSCE and SCPC websites. Activity 3. Gender analysis of the State Commission for Prevention of Corruption

The Mission will support the SCPC for the first time to carry out activities to mainstream the gender component in the creation, implementation, monitoring and evaluation of anti-corruption policies in the work of the SCPC. In 2024, a gender analysis of the State Commission for the Prevention of Corruption will be conducted, which will be the first gender analysis of this anti-corruption body in North Macedonia and the wider region. Gender analysis of the SCPC will be based on a customized Methodology for the inclusion of gender aspects in the work of the SCPC, taking into account the UNODC guidelines for the inclusion of the gender perspective in anticorruption projects/programs.¹
